It has been proven many times in various countries, both by individuals and by controlled groups, that improved study and examination techniques can strengthen a candidate's mastery of a subject and increase his or her examination scores significantly. In this regard, the Institute is organising a talk to help students to improve their examination techniques. The talk will provide students with useful tips on how to tackle examination problems and avoid pitfalls generally encountered by examination candidates.
