Among other prized personal techniques, you’ll learn about the 3 cornerstones of Buffett’s investment philosophy, including the “margin of safety,” and the critical importance of investing within your circle of competence.

You’ll also learn about some of Buffett’s greatest mentors and hear about the lessons they taught him that influence his decisions to this day. You’ll find out why the world’s greatest investor believes that all investing is value investing, and learn precisely how Buffett calculates a stock’s value and how it would change your investing habits if you did the same things. And you will learn to recognize the never-before-seen “Mr. Market,” the fictional character created by Buffett’s professor to help explain the two extremes of the stock market: fear and greed.
