## NOTES:

- (i) The Admitting Examination of MICPA will be conducted once a year in the month of November with effect from 2010.
- (ii) The MICPA examination is held in Kuala Lumpur, Kota Kinabalu, Kuching, Sandakan, Kuantan, Ipoh, Penang and Johor Bahru. The candidate should state the centre he desires to sit for the examination. However, the Council reserves the right to allocate the candidate to another centre if necessary.
- (iii) The Registration Form is to be completed and returned to the MICPA Secretariat with the appropriate fees and documents supporting items 10 & 11 of the form. All photostat copies of documents must be certified true by the referee completing item 13 of this form.

Candidates who have previously been admitted to the MICPA examination are not required to re-submit the supporting documents mentioned above.

- (iv) Members of CPA Australia are required to sit for Modules C, D, E and F. Associate members of CPA Australia must have completed the CPA programme before they are eligible to sit for the MICPA examination.

Graduate and Associate members of CIMA are required to sit for Business & Company Law and Modules C, D, E and F.

- (v) Members of the following professional bodies are eligible to sit for the MICPA Admitting Examination:

- The Institute of Chartered Accountants in England & Wales
- The Institute of Chartered Accountants of Scotland
- The Institute of Chartered Accountants in Ireland
- The Institute of Chartered Accountants in Australia
- New Zealand Institute of Chartered Accountants
- The Canadian Institute of Chartered Accountants
- The Association of Chartered Certified Accountants
- American Institute of Certified Public Accountants

Members of ACCA (Affiliate and Associate) who have not undertaken Paper P7, *Advanced Audit and Assurance* (or equivalent paper, Paper 3.1 – *Audit & Assurance Services*) are also required to pass Module E – *Advanced Auditing & Assurance* before sitting for Admitting Examination.

In the case of ACCA members who have passed the Malaysian variant of ACCA's Paper P6 or Paper 3.2 Advanced Taxation, they will only be required to pass Paper 1, Regulatory & Financial Reporting Framework of Malaysia, of the MICPA Admitting Examination.

Candidates who have undertaken Paper P7 or Paper 3.1 and Paper P6 or Paper 3.2 are required to attach a certified true copy of the result slip from ACCA that states that they attained a pass for the papers, to the examination entry form for the Admitting Examination.

- (vi) The Malaysian Taxation and Regulatory & Financial Reporting Framework of Malaysia papers may be taken in the same or separate sitting. A candidate who passed one of the two papers in a sitting shall be awarded a provisional pass in that paper which is valid only for 3 years following the sittings at which the provisional pass was awarded and the candidate shall be given a maximum of 4 attempts to pass the second paper within this period.
