## NOTE

- 1. The application for transfer of Stream or Training Supervisor must be lodged with the Institute for registration within one month of the date of transfer.
- 2. In the case of a transfer from Stream I to Stream II or transfer to a new Training Supervisor in respect of a Stream II student, the application form must be accompanied by the following documents:
  - (a) A release letter from the current Stream I Principal or Stream II Training Supervisor on the business letterhead of the Approved Training Organisation (ATO).
  - (b) A letter from the new Training Supervisor confirming the date of commencement of employment of the registered student on the business letterhead of the ATO.
  - (c) A copy of the membership certificate if the new Training Supervisor is not a member of the Institute. (Training Supervisor must be a member of the Institute or a member of one of the professional bodies approved by the Institute).
- 3. In the case of a transfer from Stream II to Stream I, the application form must be accompanied by the following documents:
  - (a) A release letter from the current Training Supervisor on the business letterhead of the ATO.
  - (b) Three copies of duly signed Stream I Training Contract.
- 4. The requisite period of practical experience to be obtained by a registered student for purposes of admission to membership of the Institute may be recognised on an accumulative basis as follows:
  - (a) any practical experience of less than 12 months duration in an ATO will not be recognised;
  - (b) the lapse of time between two consecutive periods of practical experience must not exceed 12 months.

The above regulation applies to both Stream I and Stream II students.

5. The application for transfer must be accompanied by a fee of RM265 in the form of bank draft, cheque or postal order made payable to "The Malaysian Institute of Certified Public Accountants" or "MICPA".

A penalty of RM265 will be imposed where the application for transfer is lodged with the Institute more than 30 days from the date of transfer.
