A learning edge

In 2009, the MICPA signed a MoU with the Institute of Chartered Accountants in

training organisations (ATOs).

The MICPA is currently working with various accredited public and private universities in Malaysia to identify suitable candidates who are interested to pursue the Advanced Stage Examination of the MICPA Programme, while pursuing their final year of an accredited four-year Bachelor of Accountancy degree programme.

Under the SSP, the approved accounting firms or approved training organisations will sponsor students who are interested to pursue two modules of the Advanced Stage Examination (ASE) — Taxation and Financial Reporting modules of the MICPA programme.

In return, the students will be required to work for the approved accounting firms or approved training organisations during their six-months internship as well as upon completion of their Bachelor of Accountancy degree programme for a period of not less than three years.

BDO Malaysia managing partner Datuk Gan Ah Tee advises students who are keen to pursue a career in accountancy to choose a professional body and training employer or organisation that will provide adequate support and mentoring. Administrative sup-port, study leave, or even a dedicated learning department — all these will go a long way in facilitating the student's journey towards becoming qualified.
