# Excellence rewarded

Two categories of awards presented were:

- 1) Excellence Award for The Most Outstanding CPA Student. This award is bestowed on the best all-round CPA student who has recently completed the MICPA-ICAA professional examinations
- 2) Excellence Awards for Best Accounting Graduates. This award is presented to the top accounting graduate from each of the accredited local universities that offer the Bachelor of Accountancy qualification.

The Excellence Award for The Most Outstanding CPA Student 2012 was won by Tara Ong Vi Ling who is currently working with PwC, Malaysia. Tara enrolled as a candidate of the joint MICPA-ICAA Programme in June 2010 and was the top scorer for two out of five modules of the Advanced Stage Examination.
