Road to becoming an accountant

Because of the partnership between MICPA and ICAA, graduates of the Programme are entitled to use the designations 'CPA (Malaysia)' which stands for 'Certified Public Accountant' and 'CA (Australia)' – 'Chartered Accountant'.

You may be wondering – what's the similarity between a CPA and a CA? The answer is – both terms represent an accountant who has met requirements in education, examination, experience and training that certifies them to provide a broad range of financial services to their clients in both public practice and the private sector. They are bound by standards set by the professional body to regulate professional conduct amongst its members.

The term 'Chartered Accountant' came into being in the 19th century in England and Scotland and was used to designate accountants who had a royal charter granted to them under Queen Victoria. Members of accounting bodies incorporated under the royal charter use the CA designation in a number of Commonwealth countries that include Australia, Canada, India, New Zealand, Nigeria, Pakistan, South Africa, and the United Kingdom.

For countries not part of the royal colony, there were no royal charters to be obtained and hence the 'Certified Public Accountant' designation was coined, originally by the American Institute of Certified Public Accountants, and is used by other countries such as Japan, Hong Kong, Malaysia, Singapore, China and Korea, to name a few. The CPA designation represents the result of rigorous certification exams and the fulfilment of other mandatory requirements in order to be able to practice accounting as a professional, similar to what is required of a CA.

As a professional accountant, your career can take you anywhere – to the heights of being leaders of top organisations, a business consultant who helps other organisations in their strategies to become more profitable, or even running your own business and growing it into a conglomerate. The possibilities are endless. The training you get along the way on your journey to being a CPA or CA gives you invaluable knowledge and skills that will make you highly sought after.
