# MICPA Students Sponsorship Programme



The Students Sponsorship Programme (SSP) was designed to propel high-achieving accounting students into the profession by linking them to established top-tier organisations. The organisation provides a fertile training ground for these students who will intern with them for 6 months whilst pursuing 2 modules of the MICPA-CAANZ Programme, sponsored by the organisation. Upon completion of their undergraduate degree programme, SSP candidates will be offered a permanent position in the sponsoring organisation where they will complete the remaining 3 modules of the MICPA-CAANZ Programme. After gaining 3 years of relevant practical working experience, candidates qualify for full MICPA and CAANZ memberships which entitle them to use the designations Certified Public Accountant (Malaysia) and Chartered Accountant (ANZ).

- ▶ Obtain internship placement in a top-tier organisation
- ▶ Receive sponsorship for the MICPA-CAANZ Programme
- ▶ Secure a job offer before graduation

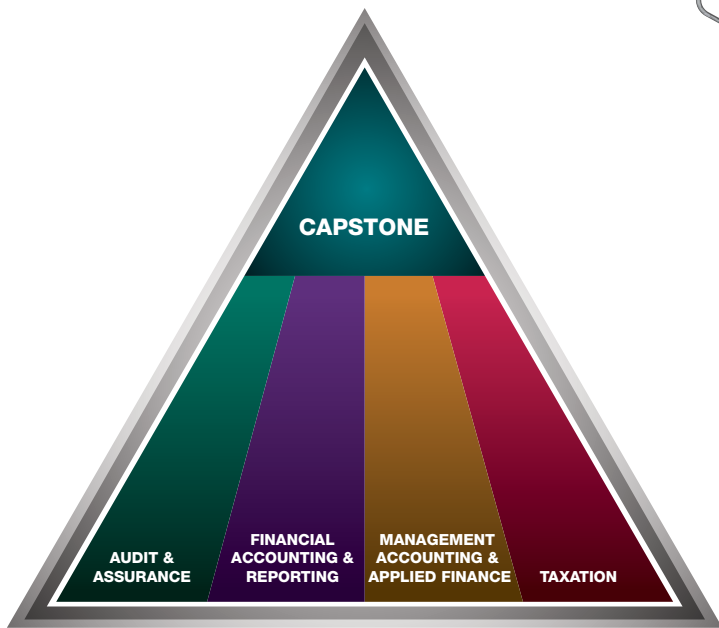


## SSP is for You!

The SSP is open to candidates who meet the following minimum criteria:

- ▶ Must be a Malaysian citizen
- ▶ Pursuing final year of a 4-year Bachelor of Accounting degree programme accredited by MICPA
- ▶ Minimum CGPA of 3.35 after completing 3 years of the Bachelor of Accounting degree programme
- ▶ Active participation in extra-curricular activities
- ▶ Fluency in written and spoken English is critical (MUET Band 3 out of 6)

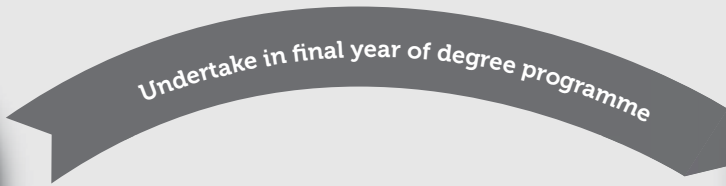
