Award winners, Gold Medal winners and graduates of the MICPA-ICAA Programme recognised at the Excellence Awards event held recently.

Excellence rewarded

It was an exciting and joyous evening at the Excellence Awards event organised by The Malaysian Institute of Certified Public Accountants (MICPA) and the Institute of Chartered Accountants Australia (ICAA) where high-achieving young Malaysians were honoured for their outstanding performance in their pursuit of a professional qualification in accounting.

The ceremony was held on Sept 26, with proud parents and friends attending to show their support for all 72 individuals who were recognised for their achievements that night.

Two categories of awards were presented, namely:

- Excellence Award for The Most Outstanding CPA Student – This award is bestowed to the best all-round CPA student who has recently completed the MICPA-ICAA professional examinations;
- Excellence Awards for Best Accounting Graduates – This award is presented to the top accounting graduate from each of the accredited local universities that offer the Bachelor of Accountancy qualification.

The Excellence Award for The Most Outstanding CPA Student 2011 was won by Tai June Lee who is currently working with PricewaterhouseCoopers Malaysia.

Lee enrolled as a candidate of the joint MICPA-ICAA programme in July 2009 and achieved the best performance in three out of five modules.

She was thereby awarded Gold Medals for the Financial Accounting and Reporting, Taxation and Management Accounting and Analysis modules in 2009 and 2010.

She has since been admitted as a MICPA member.
