ACCOUNTING is one of the rare fields of study in commerce that can lead to professional status alongside the ranks of doctors, lawyers, engineers and pharmacists, to name a few. The expertise, knowledge and experience held by professional accountants have made them trusted advisers and strategists to businesses. However, the path from an accounting degree holder to a professional accountant is not easy and therefore, accurately fits the adage "the road less travelled".

In today's competitive environment, it helps to have an edge especially when it comes to securing a future career. The MICPA-CAANZ Programme is a dual qualification jointly offered by The Malaysian Institute of Certified Public Accountants (MICPA) and Chartered Accountants Australia and New Zealand (CAANZ) – two highly regarded professional accounting bodies with global recognition. Programme graduates who have met the required three-year work experience and training can automatically become members of both bodies.
