NOTE

All students registered under Stream III are required to transfer their registration to Stream I or II upon completion of the MICPA-CAANZ Programme and commencement of work with Approved Training Employer (ATE). Visit www.micpa.com.my/resources/approved-training-employers/ for the list.

Students who have found employment with an approved accounting firm are required to transfer their registration to Stream I and students who have found employment with an approved training organisation (Commerce, Industry or public sector) are required to transfer to Stream II.

The transfer of registration must be executed within a grace period of **12 months from the date the results for the final module of the MICPA-CAANZ Programme are released.**

1. In the case of a transfer from Stream III to Stream I, the application form must be accompanied by the following documents :
 - (a) Statement of Academic Record (transcript) from MICPA confirming that the student has completed all the modules of MICPA-CAANZ Programme.
 - (b) Three copies of duly completed Stream I Training Contract.

2. In the case of a transfer from Stream III to Stream II, the application form must be accompanied by the following documents :
 - (a) Statement of Academic Record (transcript) from MICPA confirming that the student has completed all the modules of MICPA-CAANZ Programme.
 - (b) A letter from the employer confirming the date of commencement of employment on the business letterhead of the ATO
 - (c) A copy of the membership certificate of the Training Supervisor if he/she is not a member of CPA of the Institute. (Training Supervisor must be a member of CPA of the Institute or a member of one of the professional bodies at least 3 years of membership approved by the Institute).

3. The requisite period of practical experience to be obtained by a registered student for purposes of admission to membership of the Institute may be recognised on an accumulative basis as follows :
 - (a) any practical experience of less than 12 months duration in an ATO will not be recognised;
 - (b) the lapse of time between two consecutive periods of practical experience must not exceed 12 months.

The above regulation applies to both Stream I and Stream II students.

4. The application for transfer must be accompanied by a fee of RM250 in the form of bank draft, cheque or postal order made payable to "*The Malaysian Institute of Certified Public Accountants*" or "*MICPA*".
